2 Minutes.

The Full Council minutes of the 13th June 2023 were AGREED as a true and correct record. PROPOSED Cllr J Baker, seconded Cllr L Cooper.

None. It was mentioned that a pilgrim gentleman was currently staying in the Church and would be allowed to use the Village Hall lavatory, until the Vicar had found alternative accommodation.

5 Public Participation and Reports.

- 5.3 Police Matters. None
- 5.4 Church Mound: update from Malcom. N Adams gave a brief background and informed Council that a survey had taken place to determine the amount of spoil to be removed. It was mentioned that Council should apply for Planning Permission.
- 5.5 Members of the Public. A member of the public raised concerns of an overhanging Tree over a power cable on the River Green. Clerk to contact UK Power and request a site visit.

A comment was made to look into having a temporary bin during the summer months to keep down the littler accumulating on the River Green.

The white lines between Ringland Road, Costessey Lane and The Street, in front of the Pub, were now faded. N Adams suggested it could be added to the list of things to look at for the Rangers during their visit to Ringland.

It was mentioned that the road leading to the bridge, coming from Ringland going towards Taverham had a slight bump and needed to be looked at. Clerk to report it on NCC Highways.

- 7.2 To note Streetscene Inspectors are due to visit Ringland on 24th July 2023 onwards if there is work identified for their attention. Clerk to collate a list (from item 5.5) and submit to the Rangers during their visit in Ringland.
- 7.3 To consider the Environmental Stewardship Scheme: S Addington. L Cooper informed Council that following an application to the RPA a formal Mid Tier Agreement required approval. Recommendation to submit the Agreement as it would benefit Ringland Parish Council meet environmental aims over a five-year period. Proposed N Adams, seconded L Cooper.

A general update was given and it was mentioned that despite objections the A47 project will commence in December just before Christmas. NWL business case had recently passed, but there had been a lot of pressure from NCC due to reduced spending money, slowing projects down to 2 3 years if not longer. N Adams reassured that he will continue to monitor.
